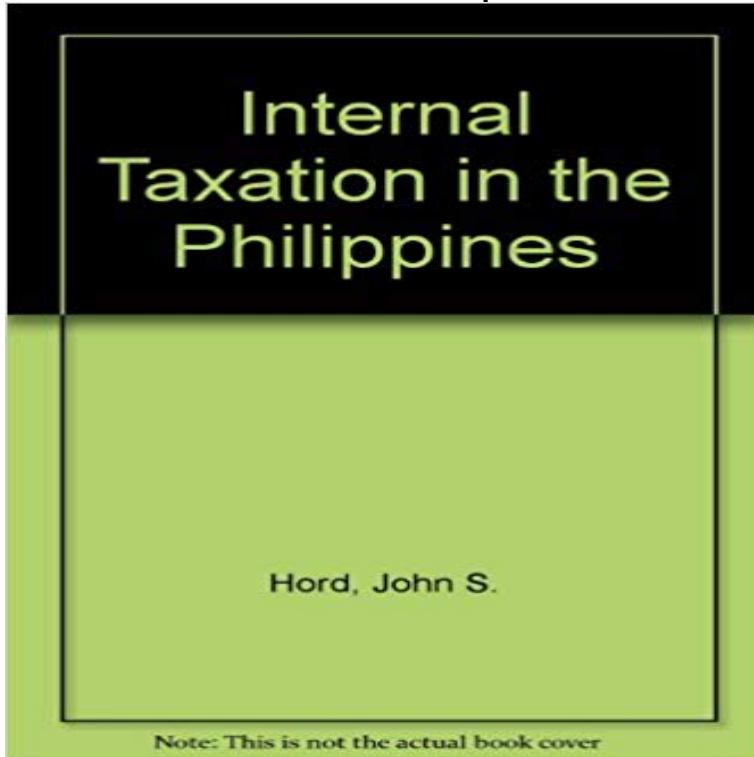


Internal Taxation in the Philippines (The Johns Hopkins University studies in historical and political science)
