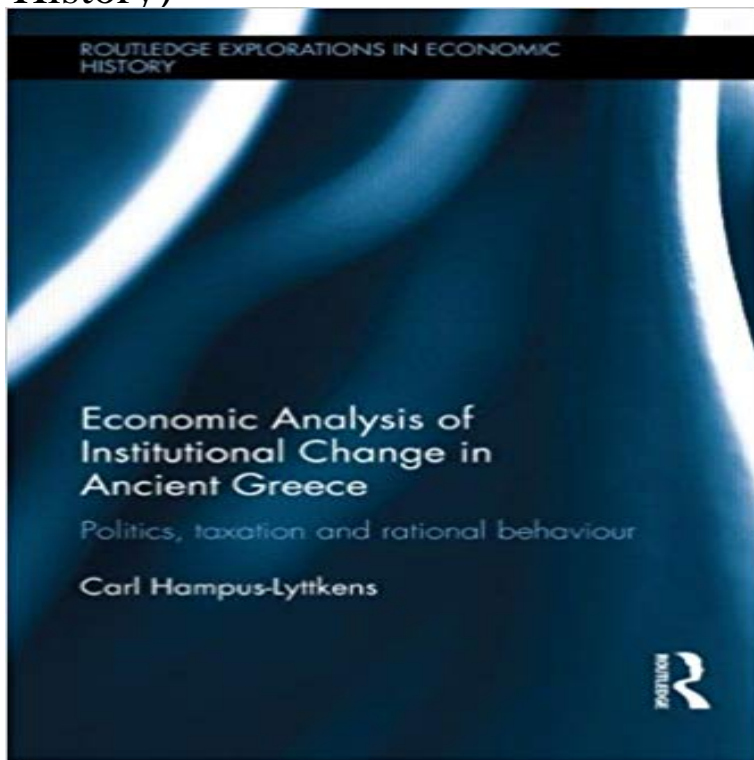


Economic Analysis of Institutional Change in Ancient Greece: Politics, Taxation and Rational Behaviour (Routledge Explorations in Economic History)
